Carnegie Corporation of New York was created by Andrew Carnegie in 1911 to promote “the advancement and diffusion of knowledge and understanding.” Under Carnegie’s will, grants must benefit the people of the United States, although up to 7.4 percent of the funds may be used for the same purpose in countries that are or have been members of the British Commonwealth, with a current emphasis on sub-Saharan Africa. As a grantmaking foundation, the Corporation seeks to carry out Carnegie’s vision of philanthropy, which he said should aim “to do real and permanent good in this world.”

2007: Strengthening Successful Programs While Preparing for Change

Throughout 2007, as the work of the Corporation moved ahead, a 12-month review of the foundation's programmatic work and administrative configuration was also under way. Led by President Vartan Gregorian, it included input from grantees, academic experts and the philanthropic community. The outcome would not be fully realized within the Corporation until the following fiscal year, but it was already possible to see emerging areas of change, which began to influence this year's work and set the stage for the impending transformation. Two important examples of this transition are an increasing level of programmatic integration, and a move toward a more evidence-based strategy.

In 2007, the **Education Program** began its fourth year of *Advancing Literacy*, supporting groundbreaking work that continued to command attention throughout the field. Program staff paved the way for several strategic investments, among them teacher education, materials development, writing interventions for middle and high school students and shap-

ing of state policy. (The eleven institutions of higher education supported by *Teachers for a New Era* have designed and implemented pupil learning growth pilot studies aimed at producing evidence-based strategies, and have moved toward implementation of university-run induction programs for graduates who are novice teachers). In *Urban School Reform*, data

from the *New Century Schools* program, which supports reform in the New York City school system, revealed the design model had a significant positive impact on graduation rates.

Strengthening of universities and enhancement of opportunities for women in higher education in South Africa, Tanzania, Uganda, Nigeria and Ghana continued to receive support from the **International Development Program** while evaluations were in progress that could influence the work that is nearing its ten-year mark. Grants for national and public libraries in South Africa brought these model library projects to near completion, while work supported by collaborative grants to selected libraries in universities within the Partnership for Higher Education in Africa got underway. Partnership universities in Tanzania and Uganda received final grants toward transformation and capacity building.

The **International Peace and Security Program** renewed its focus on how core values could be expanded and enhanced in light of changing security concerns while, at the same time, a number of programs came to a close. In seeking to develop more effective responses to the issue addressed by the Corporation's *States at Risk* subprogram, support was provided for projects ranging from development of models and early warning for states at risk to constitutional design and state building. As mature programs entered their closing stage, a number of final grants in the *Biological Weapons* sub-area went toward strengthening the link between research and security policy communities. And in the *Russia and Eurasia* subprogram, the largest single grant provided final support for the highly successful Centers for Advanced Study and Education (CASEs) in Russia.

The **Strengthening U.S. Democracy Program** aims to increase civic participation, including voting and other forms of community engagement. Immigrant civic integration in particular was emphasized over the past year, with support for the work of the Four Freedoms Fund collaborative, which facilitates the efforts of grassroots immigrant groups nationwide. Continued support was given for voter registration/education activities leading up to the 2008 election and for ensuring implementation of the Help America Vote Act. Areas that wound down were the successful *Youth Civic Education* subprogram; strengthening of the nonprofit and philanthropic sector; and campaign finance reform.

The **Carnegie Scholars Program** continued to support outstanding individuals focusing on the study of Islam and the modern world. Twenty-one scholars were selected this year. Grants were given to pursue such topics as "Do Muslim Women have Rights?" "Reforming Islam in the Axis of Evil" and "Financial Practices and Networks in Islamic Countries: Implications for the Financial War on Terror."

With the natural conclusion of a number of Corporation programs—a few after ten-year commitments—the integration of critical issues and Corporation concerns such as democracy, global educational competitiveness and the U.S. role in the world, ensured the foundation's renewed focus on its mission and values as well as the potential for greater coherence and impact in grantmaking.

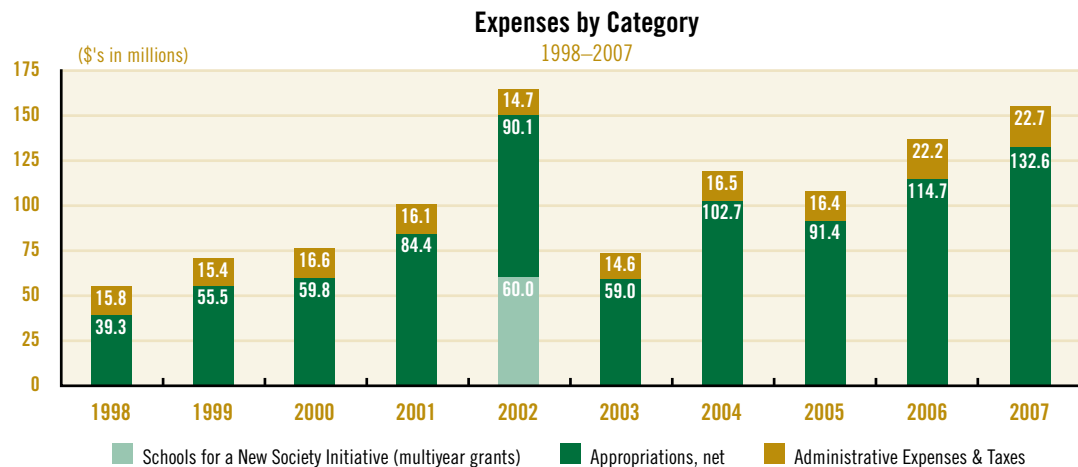
Financial Highlights

Appropriations and Expenses

For the ten years ended September 30, 2007, the Corporation awarded 4,764 grants totaling \$889.6 million and incurred expenses of \$134.0 million for direct charitable activities

and administrative expenses, excluding investment expenses, and \$37.0 million for taxes, for a total of \$1,060.6 million.

The graph below illustrates the growth in expenses by category over the ten-year period ended September 30, 2007.



Each year the trustees appropriate funds to be used for grants and for projects administered by the officers. Many of the grants involve multiyear commitments. In the fiscal year ended September 30, 2007, 35 percent of the appropriated funds were paid within the fiscal year. Appropriations, net of refunds and cancellations, totaled \$132.6 million, compared to \$114.7 million in the preceding year. The increase in 2007 in appropriations is mainly attributable to the awarding of a total of \$14 million in grants to revitalize New Orleans' Intellectual Infrastructure in the wake of Hurricane Katrina.

Program management and direct charitable activities expenses were \$12.2 million in the fiscal year ended September 30, 2007, compared with \$10.9 million in the previous fiscal year. Included in these amounts, are direct charitable activities of \$3.5 million in 2007

and \$3.3 million in 2006. Direct charitable activities are services provided directly to other exempt organizations, governmental bodies and the general public. Such services include providing technical assistance to grantees and potential grantees, conducting educational conferences and research, publishing and disseminating educational materials, and serving on boards of other charitable organizations or public commissions.

General administration expenses were \$3.8 million in 2007 and \$3.5 million in 2006.

Taxes

Under the provisions of the Tax Reform Act of 1969, Carnegie Corporation as a private foundation is subject to a federal excise tax of 2 percent on income and realized capital gains. However, under the Tax Reform Act of 1984, the rate is reduced to 1 percent if the foundation maintains its average expense rate of the previous five years and, in addition, spends the tax savings. The Corporation did not meet the requirements for the reduced tax rate in either 2007 or 2006. Excise tax expense for FY2007 was \$6.1 million. During 2007, the Corporation had unrelated business income of \$1.2 million from certain investment partnership activities. Taxes of \$.6 million on this income are calculated using applicable corporate tax rates. Deferred tax liability represents the potential tax (at 2 percent) on gains as yet unrealized as well as a book to tax timing difference. In 2007, the Corporation also provided for estimated taxes of approximately \$11,000,000 arising on unrealized gains in certain investment partnerships that were considered to be realized excise and unrelated business income for federal and state tax purposes.

Audit by Independent Accountants

The bylaws provide that the Corporation's accounts are to be audited each year by an independent public accountant. Accordingly, the firm of McGladrey & Pullen, LLP audited the Corporation's financial statements as of and for the year ended September 30, 2007. The Corporation's financial statements, together with the independent auditors' report, appear on the following pages.

Independent Auditor's Report

Goldstein Golub Kessler LLP's report dated December 21, 2006, expressed an unqualified opinion on those statements.

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

In our opinion, the 2007 financial statements referred to above present fairly, in all material respects, the financial position of Carnegie Corporation of New York as of September 30, 2007, and the results of its operations and its cash flows for the year then ended in conformity with accounting principles generally accepted in the United States of America.

Notes to Financial Statements

September 30, 2007 and 2006

(1) ORGANIZATION:

Carnegie Corporation of New York (the "Corporation") is a philanthropic grantmaking foundation that was created by Andrew Carnegie in 1911 to promote the advancement and diffusion of knowledge and understanding. The Corporation has a policy of selecting a few areas at a time in which to concentrate its grants. The Corporation is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code; however, the Corporation is liable for federal excise taxes (see note 5).

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

The accompanying financial statements have been prepared on the accrual basis of accounting.

Fixed assets are stated at cost. Depreciation is calculated on a straight-line basis over the estimated useful lives of the related assets ranging from five to ten years. Leasehold improvements are amortized over the remaining life of the lease.

Grant appropriations, including multi-year grants, are recorded as an expense and a payable when grants are approved and communicated to the grantees. Grants payable is expected to be paid as follows: approximately \$67 million within one year and the remaining balance within three years.

For purposes of the statements of cash flows, cash includes all cash held in bank accounts at September 30, 2007 and 2006.

The resources of the Corporation consist of permanently restricted and unrestricted net assets. Permanently restricted net assets represent the original sums received from Andrew Carnegie who, by the terms of the conveying instrument, stipulated that the principal may never be expended; however, the income is expendable. Unrestricted net assets are not subject to donor-imposed restrictions.

Contributions are recognized as revenues in the period received. All revenues in 2007 and 2006 were unrestricted or were restricted and released from restriction during the same period.

In 2006, the Corporation served as a fiscal agent for the benefit of specified school districts participating in the Corporation's Schools for a New Society initiative and provided technical assistance and evaluation services to said districts. In the accompanying financial statements, \$858,451 was recorded as revenue in 2006.

The fair value of investments has been determined as indicated in note 3. The carrying amounts of the Corporation's other financial instruments approximate fair value because of their short maturity.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Notes to Financial Statements

September 30, 2007 and 2006

In September 2006, the Financial Accounting Standards Board (“FASB”) issued Statement of Financial Accounting Standards No. 157, *Fair Value Measurements* (“SFAS No. 157”). SFAS No. 157 defines fair value, establishes a framework for measuring fair value, and expands disclosures about fair value measurement. SFAS No. 157 also emphasizes that fair value is a market-based measurement, not an entity-specific measurement, and sets out a fair value hierarchy with the highest priority being quoted prices in active markets. Under SFAS No. 157, fair value measurements are disclosed by level within that hierarchy. This Statement is effective for fiscal years beginning after November 15, 2007. The Corporation is currently assessing the potential effect of SFAS No. 157 on its financial position, results of operations and cash flows. The adoption of SFAS No. 157 is not expected to have a material impact on the Corporation’s financial position, results of operations or cash flows.

In July 2006, the FASB issued Interpretation No. 48, *Accounting for Uncertainty in Income Taxes—an interpretation of FASB Statement No. 109* (“FIN 48”). FIN 48 clarifies the accounting for uncertainty in income taxes recognized in an enterprise’s financial statements in accordance with FASB Statement No. 109, *Accounting for Income Taxes*. FIN 48 prescribes a comprehensive model for recognizing, measuring, presenting and disclosing in the financial statements tax positions taken or expected to be taken on a tax return. FIN 48 is effective for fiscal years beginning after December 15, 2007. The cumulative effect of applying the provisions of FIN 48, if any, will be reported as an adjustment to the opening balance of retained earnings for the fiscal year of adoption. The adoption of FIN 48 is not expected to have a material impact on the Corporation’s financial position, results of operations or cash flows.

(3) INVESTMENTS:

Readily marketable investments are reported at fair value on the basis of quoted market prices. Limited partnerships and similar interests are reported at fair value based on financial information received from the fund managers or general partners. The fund managers or general partners determine the fair value of securities using quoted market prices, if available, or using other valuation methods. Investments in limited partnerships and similar interests totaled \$2,452,068,128 at September 30, 2007 and \$2,027,306,742 at September 30, 2006.

Included in the table above is accrued investment income of \$2,230,552 and \$2,046,318 at September 30, 2007 and 2006, respectively.

As of September 30, 2007, the market value of the Corporation's securities sold short aggregate \$63,187,161 and the proceeds aggregate \$66,826,546. Subsequent market fluctuations may require the Corporation to purchase these securities at prices that differ from the market value reflected on the balance sheet. The Corporation is using these short positions for hedging purposes and not as a speculative investment.

At September 30, 2007, the Corporation had unfunded capital commitments of approximately \$679.5 million in various limited partnership investments.

During the reporting period, the Corporation received distributions of marketable securities with a total fair value of approximately \$11.6 million from limited partnerships.

In certain cases, the Corporation uses swap contracts to invest in real estate limited partnerships. As of September 30, 2007, the fair value of these swaps, which are included in investments, was approximately \$5.5 million. Swap contracts are subject to off-balance sheet risk mainly due to the credit risk arising from the potential inability of the counterparty of the swap to perform under the terms of the contract. Based on the specific structuring of these swap contracts, the Corporation's exposure to credit risk associated with counterparty nonperformance is limited to the unrealized gain on each contract. To reduce this risk, the Corporation only enters into swaps with major U.S. broker-dealers.

Notes to Financial Statements

September 30, 2007 and 2006

In 2006, as a result of its investing strategies, the Corporation was a party to financial futures contracts. The Corporation's fixed income investment manager used treasury index futures contracts to manage the duration of the fixed income portfolio. Changes in the market value of these futures contracts were recognized in 2006 in the statements of changes in net assets, using the marked-to-market method. Index futures contracts involve, to varying degrees, elements of market risk and credit risk in excess of the amounts recorded on the balance sheets. Market risk represents the potential loss the Corporation faces due to the decrease in the value of the financial instruments in the table below. Credit risk represents the potential loss the Corporation faces due to the inability of counterparties to meet the terms of their contracts.

(5) TAXES:

The Corporation is liable for federal excise taxes of two percent of its net investment income, as defined, which includes net realized capital gains, for the year. However, this tax is reduced to one percent if certain conditions are met. The Corporation did not meet the requirements for the reduced tax in either 2007 or 2006. Therefore, current taxes are estimated at two percent of net investment income, as defined, for 2007 and 2006.

Deferred taxes represent two percent of unrealized appreciation of investments at September 30, 2007 and 2006, as qualification for the one percent tax is not determinable until the fiscal year in which gains are realized. No deferred taxes are provided for unrelated business income on unrealized appreciation as such amount cannot be estimated.

During 2007 and 2006, the Corporation had unrelated business income of \$1,173,100 and \$6,200,500, respectively, from certain investment partnership activities. Federal and state taxes of \$599,900 in 2007 and \$2,445,800 in 2006 on this income are calculated using applicable corporate tax rates and are included in the provision for taxes. In 2007, the Corporation also provided for estimated taxes of approximately \$11,000,000 arising on unrealized gains in certain investment partnerships that were considered to be realized excise and unrelated business income for federal and state tax purposes.

The Corporation paid federal excise taxes of \$5,067,000 in 2007 and \$4,706,000 in 2006. The Corporation also paid federal and state unrelated business income taxes of \$1,300,000 in 2007 and \$2,279,100 in 2006.

(6) BENEFIT PLANS:

The Corporation purchases annuities for qualifying employees under the terms of a noncontributory, defined contribution retirement plan with Teachers Insurance and Annuity Association and College Retirement Equities Fund. Retirement plan expense for the years ended September 30, 2007 and 2006 was \$1,167,800 and \$1,120,400, respectively.

In addition, the Corporation has a noncontributory defined benefit annuity plan to supplement the basic plan described above. This plan is also administered by Teachers Insurance and Annuity Association and College Retirement Equities Fund. Contributions to this plan are based on actuarial calculations. No contribution was required in 2007 or 2006. At December 31, 2006, the assets of the plan exceeded the actuarial present value of accumulated plan benefits by approximately \$680,000. Accumulation of benefits under this plan has been frozen effective April 1, 2007.

In addition, the Corporation provides certain medical benefits to its retirees. The cost of providing these benefits was \$259,300 in 2007 and \$216,800 in 2006, on a pay-as-you-go basis.

(7) LEASES:

The Corporation occupies office space at 437 Madison Avenue under a lease agreement expiring December 31, 2013.

Report on Administration

Fiscal 2007: The Year in Review

After a comprehensive review of its activities, the Corporation reorganized its administrative structure to achieve a more strategic integration of programs and to bring together the Corporation's administrative services and grantmaking processes. This reappraisal was in harmony with our historical mission and legacy, and with Andrew Carnegie's mandate to the Corporation, which stressed the importance of periodically assessing how the foundation was responding to the needs and issues of the current day.

Board and Committees

Annual elections were held at the December 7, 2006, board meeting. The trustees elected Helene L. Kaplan as chairman and Martin Leibowitz as vice-chairman through March 1, 2007. Thomas Kean was elected as chairman and Richard Riley was elected as vice-chairman, effective March 2, 2007.

The board elected members to serve on various committees for calendar year 2007.

The Corporation's four standing committees were constituted as follows:

Elected to serve on the planning and finance committee were Geoffrey Boisi, Amy Gutmann, Martin Leibowitz (through March 1, 2007), Olara Otunnu (through March 1, 2007), Janet Robinson and Raymond Smith (through June 14, 2007). Janet Robinson was subsequently elected chair by committee members.

Elected to serve on the audit committee were James Hunt, Martin Leibowitz

(through March 1, 2007), Thomas Pickering, Raymond Smith (through June 14, 2007) and Pedro Aspe, who was elected chair by committee members. Norman Pearlstine was subsequently elected to the committee.

Elected to the committee on trustees were Bruce Alberts, Richard Brodhead, James Hunt, Thomas Kean, Olara Otunnu (through March 1, 2007), William Owens and Richard Riley. Susan Hockfield was subsequently elected to the committee and James Hunt was subsequently elected chair by committee members.

Elected to the investment management committee were Fiona Druckenmiller, Martin Leibowitz (through March 1, 2007), Raymond Smith (through June 14, 2007) and Geoffrey Boisi, who was elected chair by the committee members. Janet Robinson and Kurt Schmoke were subsequently elected to the committee.

The board also elected members to four program committees. Elected to the education committee were Bruce Alberts, Pedro Aspe, Amy Gutmann, Martin Leibowitz, Olara Otunnu, William Owens and Raymond Smith. Elected to the international development committee were Bruce Alberts, Geoffrey Boisi, Fiona Druckenmiller, Ana Palacio, Norman Pearlstine, Richard Riley and Janet Robinson. Elected to the international peace and security committee were Richard Brodhead, Fiona Druckenmiller, Amy Gutmann, James Hunt, Thomas Kean, Ana Palacio, Norman Pearlstine, Thomas Pickering, Richard Riley and Janet Robinson. Elected to the Strengthening U.S. Democracy program and Special Opportunities Fund committee were Pedro Aspe, Geoffrey Boisi, Richard Brodhead, James Hunt, Thomas Kean, Martin Leibowitz, Olara Otunnu, William Owens, Thomas Pickering and Raymond Smith.

Both Thomas Kean, chairman of the board and Vartan Gregorian, president of the Corporation, serve ex officio on all standing committees. Membership on the ad hoc committee on compensation includes Thomas Kean, Richard Riley, vice chairman of the board, Geoffrey Boisi, chair of the investment management committee and Janet Robinson, chair of the planning and finance committee.

At the March 1, 2007, board meeting, trustees Helene Kaplan, Martin Leibowitz and Olara Otunnu retired from the board. The minute of appreciation for Mrs. Kaplan noted that “for more than two decades you have been a guiding light to Carnegie Corporation... Your wisdom, your vast understanding of social and world issues, particularly your knowledge of Africa, as well as your broad experience in the arenas of science, education, the arts, philanthropy and the law have enriched this institution in innumerable ways.”

The minute of appreciation for Mr. Leibowitz thanked him for his “nine years of service, five as vice chair, highlighting your vital role on the Investment Management, Planning and Finance and Audit Committees and the Committee on Compensation.”

The minute of appreciation for Mr. Otunnu noted: “We are proud to have had you as a friend and colleague, and will miss your idealism, your high aspirations for this foundation, and your wisdom in our deliberations.”

At the June 14, 2007, board meeting, Raymond Smith retired from the board. The minute of appreciation read, in part: “Through the years... you have guided our work in a manner consistent with your own high ideals ... We have all benefited from your experience, knowledge and insights.”

Kurt Schmoke was elected to a four-year term beginning June 14, 2007. Mr. Schmoke is dean of the Howard University School of Law. At the September 27, 2007 board meeting Kofi Annan was elected to a four-year term effective December 6, 2007. Mr. Annan is the former Secretary-General of the United Nations.

Board Actions

At the board meeting on March 1, 2007, the trustees resolved to accept a gift of \$30 million from an individual who wished to remain anonymous. The trustees authorized the president to appropriate those funds in a manner consistent with the Corporation's mission and the donor's general intent. The grants supported small- and medium-sized arts and cultural institutions and social services providers throughout New York City.

The board also authorized the president to appropriate up to \$1,500,000 for the Academic Leadership Awards, which recognize outstanding leaders in higher education who stress the importance of community, curriculum and overall educational leadership.

At the board meeting on September 27, 2007, the board approved the use of \$60,000,000 for additional spending by the Corporation to reflect the opportunity presented by the Corporation's robust and strong endowment performance. This amount is in addition to the annual budgeted amount available for the fiscal year through the Corporation's spending rule.

Milestones

During fiscal year 2007, the Corporation undertook an in-depth review of the scope and ef-

fectiveness of its past and current grantmaking processes and programs in order to determine a future course of action, an effort that would be actualized in the following year. As part of that review, the administrative structure of the foundation was flattened in order to facilitate integration and collaboration between programs and to provide the president with the opportunity to be directly involved with the Corporation's programs during their inception, development and execution. An additional but equally important goal was to provide all the Corporation's vice presidents (with the exception of the vice president and chief investment officer and the vice president of human resources) with direct programmatic responsibility.

This process coincided with the retirement of Neil Grabois, vice president and director for Strategic Planning and Program Coordination. In view of Grabois' retirement, two new vice presidential positions were established: Deana Arsenian was appointed vice president for International Program Coordination and program director, Russian Higher Education and Eurasia, and Michele Cahill, who rejoined the Corporation's staff in 2007, was appointed vice president for National Program Coordination and Program Director, Urban School Reform. Chairs and program divisions were set aside and instead new administrative assignments were made for program officers; these include program directors and managers of specific projects.

In addition to the vice presidents for national and international program coordination, Susan King, vice president, Public Affairs, was promoted to vice president, External Affairs and Director of the Journalism Initiative, Special Initiatives and Strategy. Ed Sermier, vice president and chief administrative officer and corporate secretary, also assumed the role of director of Program Evaluation.

Ellen Bloom, vice president, Human Resources, IT and Office Services, joined the Corporation in 2007 and became an integral part of the foundation's senior management team along with D. Ellen Shuman, vice president and chief investment officer.

During fiscal year 2007, there were a number of other staff changes as the Corporation recognized professional growth with promotions and welcomed new people to the foundation. Appreciation was also expressed to departing staff members.

The following individuals joined the Corporation in fiscal year 2007: Paula Douglas, executive assistant; Kim Lew, director of investments; Talia Milgrom-Elcott, program officer, Education; Gregory Rozolsky, financial analyst; George Soule, manager of strategic communications, External Affairs and Hillary Wiesner, program director, Islam Initiative.

The Corporation bid farewell to Tiffany Garcia, mail clerk/office assistant; Mindy Hernandez, program associate; Meredith Jenkins, director of private equity; Narciso Matos, chair, International Development; Evie Nieders, executive assistant (who had been with the corporation for 33 years); Philip Sanchez, editorial assistant; David Speedie, special advisor to the president and director, Islam Project; and Connie Warren, senior program officer and director of Urban High School Initiatives.

Upon his aforementioned retirement in March 2007, Neil Grabois received a minute of appreciation from the president for his seven years of service to the Corporation. This citation read in part: "You have been not only an outstanding leader at Carnegie Corporation but also... a trusted friend and consultant. In addition, all of us have benefited from your generosity of both intellect and spirit, as well as your kindness, which have helped to advance

our work on a daily basis and to promote the long-term mission of the Corporation."

Niles Bryant was promoted from investment associate to senior investment associate. Jeanne D'Onofrio, executive assistant to the president, was promoted to chief of staff. Adam Liebling was promoted from grants associate to grants manager. Jose Rivera, office services assistant, was promoted to office services coordinator. Li Tan, investment associate, was promoted to senior investment associate.

Report on Investments

Fiscal Year 2007 Investment Performance Strongest in Corporation's History; Portfolio Exceeds \$3.0 Billion, Also a Record

Guided by the tenet that the Corporation's assets constitute a perpetual pool of capital, the Corporation's investment program is designed to weather market swings and generate meaningful returns over the long-term. Through diligent manager selection and prudent asset allocation decisions, the Corporation has succeeded in achieving its goals of maintaining purchasing power net of spending, and growing its capital corpus: over the past five years, the Corporation's assets grew from \$1,610 million to \$3,070 million, the highest valuation in its 96-year history.

Fiscal 2007 was an exceptional period for the Corporation's investment portfolio, and may prove to be a watershed year. The Corporation's return exceeded the policy benchmark, its primary measure of performance, by a substantial 3.6 percent, at 25.9 percent vs.

22.3 percent. Over three-, five-, and ten-year periods, the Corporation has also exceeded its policy benchmark substantially.

The Corporation also measures its performance vs. a peer benchmark, a secondary measure of performance, utilizing the Cambridge Associates' Over \$1 Billion Non-taxable Universe, comprised of between 70 and 80 institutions over the past decade. Against this benchmark, the Corporation's results placed it in the top decile for the one, three and five years ending September 30, 2007, and it moved into the top quartile for the decade.

The Corporation's investment performance over the decade ending September 30, 2007, is illustrated below.

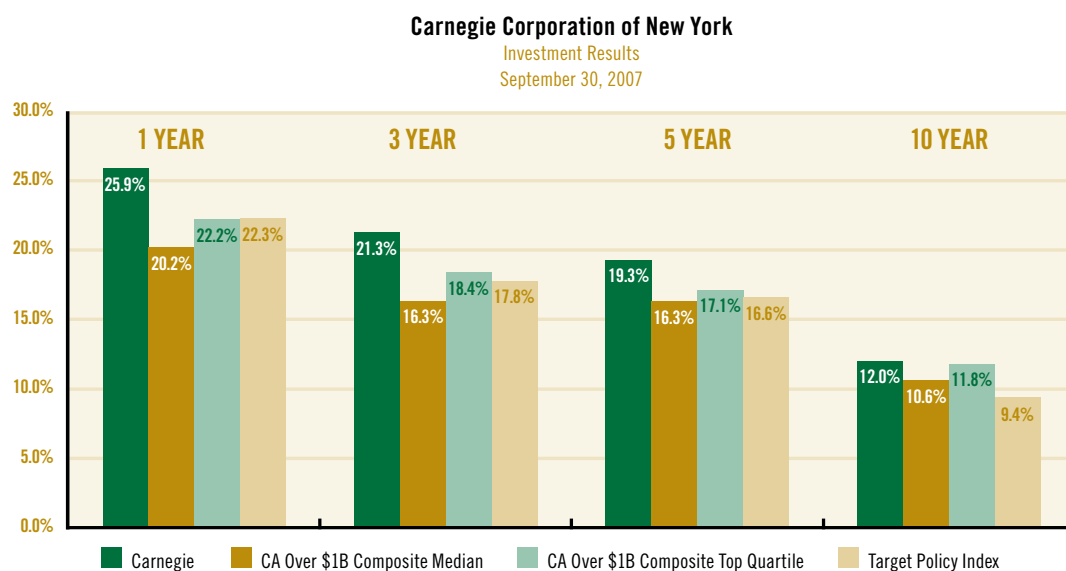
Adherents to the principles of modern portfolio theory, the Corporation's staff en-

deavors to optimize asset allocation decisions (as reflected in the Corporation's policy or target allocation) bearing in mind the return profiles, risk characteristics and correlations among competing asset classes. In comparison to peer institutions, the Corporation has a relatively high policy allocation to emerging markets and real estate and resources—an approach that has served it well—and relatively lower exposure to fixed income and developed market equities, particularly domestic names. The Corporation's asset allocation as of September 30, 2007, is illustrated below.

Outstanding performance from public equity strategies and alternative investments, including absolute return strategies, private equity and real estate and resources buoyed results on a one-, three- and five-year basis:

- The Corporation's global equity portfolio—its largest asset allocation—performed well during these periods, producing returns of 29.0, 23.5 and 24.1 percent, respectively, with emerging markets contributing significantly to these strong returns.

- Absolute return produced net returns of 24.9, 17.9 and 16.4 percent, respectively, thanks to managers' canny security selections, focus on company fundamentals, and a willingness to take concentrated positions in high conviction investment ideas.
- Private equity returned 30.1, 29.7 and 22.4 percent, respectively, exceptionally strong numbers that reflect a recovery in venture capital and a buyout environment rich with exit opportunities to both financial and strategic buyers. Private equity's performance is all the more remarkable given that the Corporation has low exposure to mega-buyout funds that have recently delivered some of the highest returns in the space.
- Real estate and resources returned 32.0, 30.1 and 21.4 percent, respectively, an outstanding run fueled by the willingness of the Corporation's managers to sell properties into a market awash in liquidity and hungry for yield. The Corporation's exposure to resource-related strategies, notably upstream oil and gas investments, also paid dividends as commodity prices surged upward.



The Corporation will occasionally tactically over- and underweight particular asset classes within prespecified ranges. For example, the Corporation has been tactically overweighting emerging markets over the past few years, given the staff's belief in its relative value and continued potential to generate strong earnings growth. This move has paid handsome dividends to the Corporation: on a one-, three- and five-year basis, the Corporation's emerging markets portfolio generated net returns of 58.6, 40.7 and 37.4 percent, respectively, making it the best performing asset class in the portfolio during those periods. The Corporation continues to make public and private equity commitments to the space, including niche managers well-positioned to capitalize on the seismic changes unfolding in China and India; however, given the tremendous run-up emerging markets have experienced, future returns are likely to be more modest and increasingly choppy, and the staff revisits its tactical overweighting decision in this light. On the other hand, the staff has tactically underweighted fixed income—owing to its inherently capped upside—utilizing this

asset class primarily as an “anchor to windward” that provides insurance against periods of capital markets stress.

Throughout most of fiscal 2007, valuations of financial assets remained rich across categories and in virtually every region of the world, a situation we, and many others, have bemoaned for several years now. Change, however, appears afoot, with risk being repriced both rapidly and dramatically. Indeed, the summer of 2007 may herald a tipping point, with sharp market declines, surging volatility and the unwinding of several large, over-levered hedge funds. Credit markets, the fuel behind much of the recent run-up in asset prices, grew increasingly skittish into the fall as lax lending practices, questionable securitization alchemy and housing market euphoria ground to a halt. The pall cast by deepening debt market contractions may prove wider and darker than optimists expect, as the leverage that powered markets skyward can cut just as powerfully in the opposite direction. Because of this inherent risk, the Corporation avoids managers and funds that use excessive leverage.

* The target policy benchmark provides a way to compare the performance of the Corporation's portfolio with appropriate market indices. Each of the portfolio's asset classes has a benchmark; the policy benchmark is calculated by multiplying the actual return of an appropriate market index (such as the S & P 500) for each class of assets by the percentage of the Corporation's portfolio that is allocated to that class. The total policy benchmark, the sum of these benchmark calculations, provides an overall measure of actual performance relative to market indices.

The Corporation has clearly benefited from bull markets over the past five years, with fiscal 2007 marking a truly remarkable and historic moment for the portfolio. But the Corporation's portfolio is also positioned defensively to ride out what may be an extremely challenging environment going forward, thanks to its substantial diversification, emphasis on fundamental manager research, bias toward bottoms-up security selection and avoidance of levered strategies. Given the perpetual mandate and irreplaceable nature of the Corporation's asset base, optimizing returns on a risk-adjusted basis over the long term remains the investment program's lodestar—an ambitious and deceptively simple goal, but, one we believe is achievable provided the Corporation's investment discipline remains intact, whatever markets may bring.
